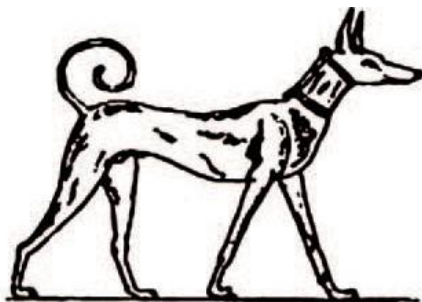

From 101 North Exit Dunne Ave. At stop turn left on Dunne Ave. then:

Day of Show Parking Lot

- On Dunne Ave, go (330 yards) to Condit Rd, turn right on Condit Rd. ½ mile to entrance to Morgan Hill Sports Complex. Pay Day of Show parking at entrance. WAZE address: 16500 Condit Rd, Morgan Hill, CA 95037.

RV Overnight Parking

- On Dunne Ave, go 0.35 miles to Condit Rd, turn right on Condit Rd, go 0.7 miles to Aquatic Center, turn left to main entrance of Morgan Hill Aquatic Center, follow curve around to RV entrance. WAZE address: 16200 Condit Rd, Morgan Hill, CA 95037.

From 101 South Exit Tennant Ave. At stop turn right on Tennant Ave. then:

Day of Show Parking Lot

- Go (330 yards) to Condit Rd, turn left on Condit Rd. .43 miles to entrance to Morgan Hill Sports Complex. Pay Day of Show parking at entrance. WAZE address: 16500 Condit Rd, Morgan Hill, CA.

RV Overnight Parking

- Go 300 yards to Condit Rd, turn left on Condit Rd, go 0.35 miles to main entrance of Morgan Hill Aquatic Center, follow curve around to RV entrance. WAZE address: 16200 Condit Rd, Morgan Hill, CA 95037.
