Only purebred Pharaoh Hounds. All entries shall be individually registered with the AKC (ILP/PAL included), the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry.

Best of Breed: Crate Pad and Slip Lead

High Scoring Singles: Stuffed Bunny Toy

First Place in each Regular Stake: Stuffed Bunny Toy

RIBBONS:

Best of Breed: Purple & Gold, High Scoring Singles: Navy & Gold, First Place:

Blue, Second: Red, Third: Yellow, Fourth: White, NBQ: Dark Green

STAKES OFFERED:

Open Stake: Any eligible Pharaoh Hound, excluding ASFA Field Champions of record, that has met the certification requirements.

Field Champion Stake: Any Pharaoh Hound ASFA Field Champion of record.

Veteran Stake: Any eligible Pharaoh Hound whose age is at least six years that has met the certification requirements. Points go toward V-FCh or V-LCM titles.

Single Stake: Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake.

Not offering Bench or Kennel Stake.

Entries will **NOT** be acknowledged by mail.

****Please DO NOT send entries with 'signature required'.****

CONDITIONS OF ENTRY:

- All entries must be one year or older on the day of the trial.
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Neutered without breed disqualifications may be entered. Hounds with breed disqualifications are ONLY eligible to enter Single Stake.
- Hounds not present at time of roll call will be scratched.
- All hounds will run twice, in trios if possible, or braces (except in the Single Stake), unless excused, dismissed or disqualified.
- Hound certification runs will be offered as time permits.
- A \$5.00 penalty will be collected for any loose hound not in competition.
- **Persons exhibiting unsportsmanlike conduct detrimental to ASFA, PHCA, any hound or person will be asked to leave the trial site.**

All first time entries MUST include a completed & signed ASFA Certification Form, AKC QC or Waiver Form (with proof of title) and a copy of the hound's registration certificate (ASFA certification waived for Single Stake entries only).

GENERAL INFORMATION:

- Please bring your own shade and water.
- A restroom will be available.
- No one, except Field Committee members, will be allowed on the field without the expressed permission of the Field Committee.
- There will be a **\$5.00 fine** for anyone not picking up after their own dog.
- PHCA assumes no liability for injury to any person or dog before, during or after the Tests and/or Trials.

- ENTRIES can be sent to the Field Secretary's address with checks made payable to "PHCA". FAX ENTRIES will not be accepted.

COVID-19 PROCEDURES

Although our event is outdoors, all participants will be required to wear a solid facial covering that completely covers the nose and mouth for any indoor location (eg the bathroom) per current Santa Clara County ordinance.

1. All participants will practice social distancing.
2. All participants will be required to sign the COVID waiver by Roll Call.
3. Roll Call will be performed as usual, with everyone socially distanced. Participants with female dogs will be asked to wipe their dogs and show the wiping material to the Inspection Committee.
4. The Huntmaster will stand six feet from the participants after inspecting blankets and slip leads.
5. At the starting line, dogs will stand six feet apart.
6. Running orders will be posted as usual, but please socially distance. If you have a smartphone, please take a photo of the running order and results and do not linger near the postings.
7. There will not be self-serve ribbons at this event.

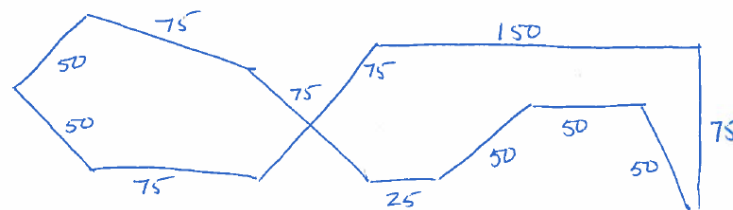
Battery powered, continuous loop lure machines will be used with white or colored plastic streamers. Back-up equipment will be available.
